The University for Peace (UPEACE), a United Nations affiliated institution based in Costa Rica, is celebrating its 30th anniversary this year. The mission of UPEACE, the Graduate School for International Leaders, is “to provide humanity with an international institution of higher education for peace with the aim of promoting among all human beings a spirit of understanding, tolerance and peaceful coexistence, to stimulate cooperation among peoples and to help lessen obstacles and threats to world peace and progress”. The Dutch Alliance for UPEACE supports this celebration by organizing a number of high-profile colloquia on topical issues to take place in The Netherlands throughout the year.

One such colloquium will be dealing with ‘The right to water and water rights in a changing world’. It will be hosted at the UNESCO-IHE Institute for Water Education in Delft, the Netherlands.

The topic is very timely: in the face of global changes, what role can law play in safeguarding basic needs and rights, including that of water? Can law be more effectively mobilized to protect vulnerable communities better against droughts, floods and other climate-related disasters? In doing so, to what extent can it contribute to world peace? As laws tend to be rigid, how can they play a more progressive role in a rapidly changing world? Currently water management is stepping away from the idea of stationarity – but what about legal issues? Are they set in stone?
